- 6. COVID-19 vaccinations. Vaccinations were offered by GC on 1/7 and 1/8/21. One member received 1st vaccination. A second was not due to a scheduling error on the part of the vaccination program. Other members were either ineligible or unable to vaccinate for other reasons. First responders are in group 1a and eligible for vaccination. The Medical Officer will inform department members of dates when vaccination appointments are available. Members will be responsible for scheduling their appointments. The Medical Officer has sent specific vaccination recommendations to all department members by email and has discussed them with members by phone. Vaccination of all members is strongly recommended. Even after vaccination, other COVID-19 mitigation measures are to be implemented while working in and with the department.
